Enclosure Guy specifies the highest quality materials available world-wide and offers a five (5) year limited product warranty on all craftsmanship. We custom manufacture our retractable patio solutions (in-house) one project at a time. Although this system has been hurricane tested many times over, it **has not been professionally engineered** by us or any other firm. Project specific engineering is available at an additional cost and undertaken by request only.

### **Warning:**

This temporary structure has not been manufactured to meet any specific building code requirements, nor have permits been requested or applied for. We recommend that in the event of severe weather or if there is any doubt concerning the safe handling and operation that you retract the entire enclosure system (if possible) and evacuate the area.

These curtains in size, area, and configuration are the equivalent of a small yacht sail and should not be taken lightly. Typically, these individual panels will contain a surface area in excess of 100 sq.ft. per panel and in a thirty (35) five mph gust, will generate a live load nearly 750 lbs. of force and should be handled with extreme respect and care.

We also strongly recommend that the end-user never leave the system unattended, if all the hold-down straps are not clipped and zipped as originally designed.

Seasonal installations should be inspected prior to use.

### **Please Note:**

Curtains will appear oversized due to a built-in shrink factor.

Smooth & neat storage using Velcro straps will reduce the potential for chafing.

DO NOT attempt to close and/or draw panels together by using the zipper sliders

## **CARE & CLEANING INSTRUCTIONS:**

Use only micro-fiber cloth to wipe off the clear vinyl, do not use bar rags, paper towels and other similar materials that will scratch it permanently.

# 210 polish and scratch remover is recommended for general seasonal cleaning and is available exclusively through Enclosure Guy by contacting the factory directly.

Zipper sliders should be dressed with lubricating wax or fluid

# 210 Plus which is a mild (paste) compound is recommended for deeper scratches.

It is strongly recommended that one responsible (key) person become familiar with the operation, care, and safe handling of your Enclosure System.
